On-Site Preparation: State Coordinator and Facilitator gather questions, issues, clarification to prepare for on-site meeting.

On-Site Meeting: Facilitator, State Coordinator and selected respondents meet on-site to discuss assessment results.

Round Two Data Collection: State provides final response to the assessors' ratings.

Round Two Analysis: Assessors review additional information from the State and, if needed, adjust initial ratings.

Facilitator prepares final report

Central Crash Data Repository and Improved Crash Data Quality- Phase I

Problem ID:

- CRSCAN receives approximately 750k crash reports annually;
- FLHSMV distributes daily copies of statewide crash data and images
- 300k of 750k crash reports require crash diagram submission;
 -CRSCAN ingestion process issues high resolution images= unreadable diagram

Geolocation-Based Crash Diagramming to Improve Crash Data Quality

Problem ID:

- Remember 300k of the 750k crash reports require diagrams;
- Diagram Tools can be expensive!
- Lack of Geo-location tool + Diagram Tool = location discrepancies

Signal Four and CAR Geocoding Tools

Problem ID:

- Duplicative efforts- storage of crash data and images;
- Duplicative efforts- crash data reconciliation

Solution- These tools will improve the data accuracy for the location of the crash by allowing FDOT staff to provide a QA/QC process against the automated processes in place providing a "verified" location.

- Single state-wide Crash Repository
- Web-based combo Geolocation + Diagram Tool
- Reduce resources spent on duplicative storage and data reconciliation efforts
